He suggested chain as the replacement material, as rope is expensive, and needs to be spliced to create the length required. The chain he suggested is virtually identical to the chain found close by on the Quay and will be durable and easy to maintain.

Councillor Christie said that the posts and rope were first introduced by the Town Council following the Port Memorial improvements and were chosen to compliment the maritime theme of the Quay. He advised that the lampposts along the Quay reflected ships masts, and the area was in close proximity to Rope Walk. He felt that rope would be safer than chain from a vehicle and pedestrian point of view.
